Central Legislation

Westlaw India also has a comprehensive database of Central Bare Acts with amendments; Bills with their status; and Ordinances. It provides complete amendment history and full text of Bare Acts since 1836 and Rules and Regulations since 1950. Besides, Westlaw India covers Notifications and Circulars sourced from 21 Ministries.
